Notice is hereby given that the Council of the London Borough of Camden on 28 November 2024 made the above Orders under sections 9 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended. The Orders will come into force on 13 January 2025.

The general nature and effect of the Orders will be on an experimental basis:-

- in Holmes Road, to provide a 'no motor vehicles' restriction applying 'at any time' to westbound vehicles, 4 metres west of the western kerb-line of Raglan Street;
- (b) in Cathcart Street, to:
 - provide a no motor vehicles restriction applying to north-westbound vehicles at the boundary of Nos. 7 and 8 Cathcart Street between 8am and 9am and between 3.30pm and 4.30pm on Mondays to Fridays inclusive;
 - (ii) provide a no motor vehicles restriction applying to south-eastbound vehicles at its junction with Holmes Road applying 'at any time';
 - (iii) remove 10.9 metres of CA-L permit holders parking space and replace it with 'at any time' waiting restrictions on the south-west side, outside Nos.
 6 to 8 Cathcart Street to allow for vehicle turning;
 - (iv) remove 5.5 metres of CA-L permit holders parking space and provide 'at any time' waiting restrictions on the north-east side, adjacent to No. 87 Holmes Road to improve sightlines;
- (c) in Willes Road, to:
 - provide a no motor vehicles restriction applying to south-eastbound vehicles at a point 4 metres south-east of the south-eastern kerb-line of Holmes Road between 8am and 9am and between 3.30pm and 4.30pm on Mondays to Fridays inclusive;
 - (ii) provide a no entry except pedal cycles applying in both directions at its junction with Inkerman Road applying 'at any time';
 - (iii) remove 11 metres of CA-L permit holders parking space and provide 11.6 metres of 'at any time' waiting restrictions on the south-west side, opposite

Nos. 38 and 40 Willes Road to allow for vehicle turning and remove 11 metres of CA-L permit holders parking space and provide 10.9 metres of 'at any time' waiting restrictions on the north-east side, outside Nos. 38 and 40 Willes Road, to allow for vehicle turning.

Exemption to the timed no motor vehicle restrictions would be provided for 'Plus Bus door to door' and 'Dial-a-ride' buses. Exemption to all the no motor vehicle restrictions would be provided for emergency services, and such other vehicles as may be authorised by the Council.

The Orders provide that in pursuance of section 10(2) of the Act, the specified officer may, if it appears essential in the interests of the expeditious, convenient and safe movement of traffic on the highway or for preserving or improving the amenities of the area through which any road affected by the Orders run, modify or suspend the Orders or any of their provisions.

The Orders are to be on an experimental basis for a maximum period of 18 months and the Council will be considering in due course whether the provisions of the Orders should be continued in force indefinitely by means of permanent Orders made under Sections 6, 45, 46 49, 124 and Part IV of Schedule 9 of the Act of 1984. Any person may object to the making of the permanent Orders for the purpose of such indefinite continuation within a period of six months beginning with the day on which the above-mentioned Orders came into operation or, if any of the Orders are varied by any other Order, beginning with the day on which the latest variation or modification came into operation. STATEMENT OF REASONS

Streets in the area around Holmes Road between Prince of Wales Road and Kentish Town Road are primarily residential in nature and home to two schools.

Large volumes of traffic use Holmes Road, as well as other streets in the area, as a cut-through to avoid the traffic lights at the junction of Prince of Wales Road and Kentish Town Road.

In order to provide children (and parents) with the opportunity to travel to and from school in a safer environment, a trial Healthy School Street (timed road closure) was introduced on Holmes Road outside St Patrick's Primary School in May 2022, in addition to an 'at all times' motor vehicle restriction on Raglan Street.

To improve access to properties on Raglan Street, the one-way southbound designation of Anglers Lane between Alma Street and Willes Road was removed.

In response to feedback received and monitoring undertaken during the trial period, these trial elements were made permanent, and several new schemes/measures were proposed, consulted upon and approved via a decision report published in November 2023.

Experimental Traffic Management Orders are required to facilitate the following traffic management proposals, as this will enable these elements of the scheme to be delivered while providing additional opportunities for monitoring and the collection of feedback from local stakeholders:

- (a) A westbound 'at all times' motor vehicle restriction on Holmes Road to reduce motor vehicle traffic volumes in the area.
- (b) An 'at all times' motor vehicle restriction on Willes Road located to the north of the junction with Inkerman Road to stop Willes Road from being used as a cutthrough for motor vehicles travelling from Prince of Wales Road to Kentish Town Road. Double yellow lines will replace certain lengths of permit holders parking space near to the road closure to allow space for vehicles to turn around.
- (c) A Healthy School Street (timed motor vehicle restriction) on Willes Road between Inkerman Road and Holmes Road (operating Monday - Friday, 8am -9am and 3:30pm-4:30pm) to discourage car trips, particularly amongst parents

and carers and provide a safe and inviting space for more walking, cycling and scooting outside Collège Français Bilingue de Londres.

- (d) a southbound motor vehicle restriction on Cathcart Street, directly to the south of the junction with Holmes Road to prevent southbound vehicles, which may otherwise travel down Willes Road, from being displaced onto Cathcart Street.
 Double yellow lines will replace a certain length of permit holders parking space in Cathcart Street near its junction with Holmes Road to improve sight lines.
- (e) a Healthy School Street (timed motor vehicle restriction) on Cathcart Street between Holmes Road and between 8 and 32 Cathcart Street (operating Monday - Friday, 8am - 9am and 3:30pm -4:30pm) to discourage car trips, particularly amongst parents and carers and provide a safe and inviting space for more walking, cycling and scooting outside Collège Français Bilingue de Londres. Double yellow lines will replace certain lengths of permit holders parking space near to the start of the restrictions to allow space for vehicles to turn around.

It is proposed that the ETO for the scheme would be in place for 18 months. The Council will carry out a full public consultation after the experimental scheme has been in place for approximately 12 months. This consultation will then, together with relevant information from other sources, inform the Council's decision as to what permanent measures may be taken for a permanent scheme, subject to funding. If approved, monitoring data will be collected on relevant streets in the general vicinity of the scheme before and during the trial.

Citation, commencement and expiry

1.1 This Order may be cited as the Camden (Prescribed Routes) (Holm Cathcart Road, Holmes Road and Willes Road) (No. 1) Experimental Traffic Order 2024, shall come into force on 13 January 2025, and will expire on 12 July 2026.

Interpretation

2.1 In this Order:-

"bus" and "pedal cycle" has the same meanings as in Schedule 1 to the Traffic Signs Regulations and General Directions 2016²;

"causing" includes "permitting";

"Council" means the Council of the London Borough of Camden;

"disabled persons badge" has the same meaning as in the Disabled Persons (Badges for Motor Vehicles) (England) Regulations 2000³;

"electric scooter" has the same meaning as in Schedule 1 to the Traffic Signs Regulations and General Directions 2016 as amended by the Electric Scooter Trials and Traffic Signs (Coronavirus) Regulations and General Directions 2020⁴;

"enactment" means any enactment, whether public general or local, and includes any order, byelaw, rule, regulation, scheme or other instrument having effect by virtue of an enactment

"motor vehicle" has the same meaning as in section 136 of the Road Traffic Regulation Act 1984;

"prescribed hours" means between 8 a.m. and 9 a.m. and between 3.30 p.m. and 4.30 p.m. on Mondays to Fridays inclusive.

2.2 Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended, applied, consolidated, re-enacted by or as having effect by virtue of any subsequent enactment.

Provisions - prescribed routes

- 3.1 No person causing any motor vehicle to proceed in Holmes Road shall, upon reaching its junction with Cathcart Street, cause that motor vehicle to enter Cathcart Street.
- 3.2 No person causing any motor vehicle to proceed in a north-westbound direction in that part of Cathcart Street which lies south-east of a point 10 metres north-west of the party wall of Nos. 5 and 6 Cathcart Street shall, upon reaching that point, cause that motor vehicle to enter into that part of Cathcart Street which lies north-west of that point, during the prescribed hours.
- 3.3 No person causing any motor vehicle to proceed in a south-eastbound direction in that part of Willes Road which lies north-west of a point 4 metres south-east of the south-eastern kerb-line of Holmes Road shall, upon reaching that point, cause that motor vehicle to enter into that part of Willes Road which lies south-east of that point, during the prescribed hours.
- 3.4 No person causing any motor vehicle to proceed in a north-westbound direction in that part of Holmes Road which lies south-east of a point 4 metres north-west of the north-western kerb-line of Raglan Street shall, upon reaching that point, cause that motor vehicle to enter into that part of Holmes Road which lies northwest of that point.
- 3.5 No person causing any vehicle other than a pedal cycle to proceed in Inkerman Road shall, upon reaching its junction with that part of Willes Road that lies northwest of Inkerman Road, cause that vehicle to enter that part of Willes Road that lies north-west of Inkerman Road.
- 3.6 No person causing any vehicle other than a pedal cycle to proceed in that part of Willes Road that lies north-west of Inkerman Road shall, upon reaching its junction with Inkerman Road, cause that vehicle to enter Inkerman Road.

Exemptions

- 4.1 Nothing in Articles 3.1 to 3.6 inclusive shall apply in relation to:-
 - (a) anything done with the permission or at the direction of a police constable;
 - (b) a vehicle being used by the ambulance, fire brigade or police purposes;
 - (c) any person who causes any vehicle to proceed in accordance with any restriction or requirement indicated by traffic signs placed pursuant to sections 66 or 67 of the Road Traffic Regulation Act 1984;
 - (d) a vehicle being used by or on behalf of the Council in the pursuance of its statutory duties;

- (e) a vehicle being used in connection with the removal of an obstruction to traffic;
- (f) an electric scooter;
- (g) any vehicle which may otherwise be authorised by the council.
- 4.2 Without prejudice to the exemptions set out above, nothing in Articles 3.2 or 3.3 shall apply in respect of:
 - (a) any vehicle registered at a residential address within either:
 - (i) that part of Cathcart Street which lies between its junction with Holmes Road and the party wall of Nos. 7 and 8 Cathcart Street; or
 - (ii) that part of Holmes Road which lies between its junction with Raglan Street and a point 225 Willes Road north-west of the western kerb-line of Kentish Town Road;
 - (b) any vehicle being used to transport a person resident in the sections of those streets described in sub-paragraph (a) above to whom a valid disabled persons' badge has been issued; or
 - (c) any vehicle being used to transport a disabled pupil to or from St. Patrick's Catholic Primary School, Holmes Road or Collège Français Bilingue de Londres, Holmes Road;
 - (d) a bus operating a 'Plus Bus door to door' or 'Dial-a-ride' service, when providing that service to a person or persons resident in the sections of those streets described in sub-paragraph (a) above.

5.1 In pursuance of section 10(2) of the Road Traffic Regulation Act 1984, the Highway Network Manager or some other person authorised in that behalf by him, may, if it appears to him or that other person essential in the interests of the expeditious, convenient and safe movement of traffic, or in the interests of providing suitable and adequate on-street parking facilities, or for preserving or improving the amenities of the area through which any road affected by this Order runs, modify or suspend the operation of this Order or any provision of it, save that no modification shall make an addition.
